

## **Uninsured Services**

These services are not covered by OHIP. Prices are determined through guidelines set by the Ontario Medical Association. They are in line with provincial standards as set by the Ontario Medical Association (OMA). Please note this is merely a reference and that the actual fee may be different at your provider's discretion. The fees are to account for the medicolegal responsibility as well as the time your physician and their administrative staff need to take away from routine OHIP-covered patient care (including outside of regular work hours) to complete these requests.

Please call or e-mail the clinic with any questions. We do not accept or handle cash payments.

## **Patient Forms/Applications:**

When completing forms, your healthcare provider will use objective information in the medical record. They cannot guarantee any outcome of the form and are limited by the completeness including legibility of records. Having a longer therapeutic relationship with the provider completing the form along with easily accessible medical records can make the task easier. If there are circumstances that require additional work to complete the form, there may be additional charges involved (appointment to gather information, perform physical exam).

Example 1. Driver's medical examination may require the form along with an updated complete physical examination as well as a urine test. (50+100+10=\$160.00)

Example 2. Attending statement or disability form with a new healthcare provider – since your healthcare provider does not know your history, they may need a separate uninsured appointment to gather history as well as an hourly rate to professionally review your old records.

It is the patient's responsibility to be aware of fees and let your healthcare provider know in advance if there may be issues with paying the fee. The fee is ONLY FOR completion of the form by your provider with the information they have – it will not be refunded if the desired outcome of the form is not attained.

You can reduce possible additional fees associated with the form by reducing the work your healthcare provider and their staff have in several ways:

- 1. Ensure the form is brought to the clinic's attention through the appropriate channel. You may personally bring it to the office or have a third-party send it by mail or fax. Forms are not appropriate for e-mail, patient messaging systems, or our secure drop-box.
- 2. Please ensure your form has your **signature and date**. Please **pre-fill the sections you are responsible for.** You may leave a note or partially complete sections within reason to give your provider context for the form.
- 3. Discuss with our administrative staff ahead of time if there are additional things needed for your form such as an appointment to discuss with your provider, a physical exam, or records that may not already be in your chart.
